Memorial Boulevard Road Repair – City coordinating with parish road general contractor to make repairs

Major Parkway Drainage – PESI working with Major Heirs on drainage study.

Sixth Street Sewer (Odor Control) – Project has begun. Waiting on cover to be fabricated.

Sixth Street Sewer (Rehab and/or Replacement – Need archive information.

Will need to coordinate with Elie Part to meet so we can go through city archives.

Riverdale Development – Making site visits as needed during construction phase. Nearing project close-out walk through.

False River Pedestrian Walkway – Submitted plans to recreational trails funding agency for review.

Bike Trail (DOTD Permit application) – Will pick up signed application sheet at meeting for submitting to DOTD.

Ourso Residence on False River – Had meetings with city and Major Thibaut. Did field work and prepared a report that was furnished to city and Major Thibaut. Next step is meeting with Major Thibaut, city of New Roads and homeowner to discuss PESI findings.

Berthier Street Extension – Met with Sal to coordinate getting started on schematic and road R/W document.

Miscellaneous – KCS Railroad – coordination with KCS engineer on road construction requirements. Sugar Fields reverse flow drainage issue corrected. Coordinating with KCS Railroad for installation of culvert at RR tracks and Gretchen Street.

He also asked that a letter be sent to DOTD (Dept. of Transportation and Development) regarding the New Roads signs near the Audubon Bridge. He stated that the font size needs to be larger and the signs need to be relocated.

Mr. White asked that the "Welcome to New Roads" sign be removed.

Before adjourning, Mr. Davis, Mr. Jewell and Mr. Daisy expressed their condolences and memories of former Mayor Sylvester Muckelroy.
