**CITY OF NEW ROADS CITY COUNCIL
REGULAR MEETING**

June 5, 2018

The New Roads City Council met in regular session at 5:30 o'clock P.M. Tuesday, June 5, 2018 at the City Hall in New Roads, Louisiana. Mayor Anthony Daisy called the meeting to order. A roll call resulted as follows:

Rep. Major Thibaut – Capital Outlay announcement

Major Rep. Thibaut appeared before the council to announce the approval of a Capital Outlay appropriation in the amount of \$1,000,000.00. The funds will be used for the Industrial Park Improvement project.

Mrs. Rosetta Nelson – Complaint of harassment by the city

Due to a previous engagement, Mrs. Nelson cancelled her appearance before the council.

Discussion of extension of road through Civic Center walking trail

Several residents of Major Subdivision appeared before the council to voice their concerns for an extended road through the Civic Center walking trail.

Mr. White explained that there are no plans or funds available to construct an evacuation route through the walking trail.

Several residents also questioned the drainage in the subdivision and the city's plans to install larger culverts and clean the ditches. After some discussion, Sal Rinaudo and Cletus Langlois were asked to prepare a quick study on the drainage.

Appointment to Main Street Board

Mayor Daisy recommended that Becky Jarreau and Cleve Coats be appointed to the Main Street Board.
