June 18, 2019

#### Adoption of Minutes of Meeting of June 4, 2019

### **Public Comment**

Desiree Lemoine of Pointe Coupee Electric Membership appeared before the council to respond to questions about a recent advertisement that read "Do you know you may have a choice in utility providers".

She stated that the advertisement is a part of her organization's marketing campaign and is no way in competition with the franchise agreement with the city.

#### **Engineer's Report**

Cletus Langlois reported that the coating process for the Major Parkway Lift Station project will begin in three days. He also reported that he is working on plans on the Giselle and Gretchen Street drainage issues.

#### Representative Jeremy Lacombe - Update on 2019 Legislative Session

Mr. Lacombe gave a recap of the 2019 legislative session that included the following items:

- Redirection of eight million dollars in BP oil money to various projects.
- \$125 million to West Baton Rouge for the Hwy. 415 connector project.
- Annexation of the Pointe Coupee Parish Port with the Greater Baton Rouge Port.
- Capital Outlay appropriation of \$12 million dollars to Pointe Coupee Parish for various projects.
- \$20 million dollars budgeted for programs for 0 3 year olds.
- Teacher pay raise of \$1000.00.
- Support staff and personnel pay raise of \$500.00.
- Foster care age increase to 21 years old

In closing, Mr. Lacombe announced his plans to run in the October 2019 election.
