Council Reports

Ms. Nelson reported a complaint of tall grass at 709 Tuminello Street and requested that the city cut the grass. She also reported a drainage complaint at 416 Martin Drive.

Mr. Davis questioned the culvert issue at Bernard, Louis and Rita Streets.

Mr. Smith thanked the public works department for handling the street light issue in Sugar Fields Subdivision.

Ms. Nelson asked for clarification on the previously reported problems on Scott Street. Paul Seawell explained that the lines covered by overgrown vines belong to AT & T and Fidelity Cable lines and not the city. It was recommended that a letter be drafted to AT & T and Fidelity Cable regarding the overgrown vines.

Mr. Smith mentioned the street banners for Catholic and the temporary suspension of the ordinance to allow the banners to be installed. He reminded the council that the ordinance needs to be amended.

Ms. Nelson announced that the non-profit organization "Driven" would be conducting a flag football tournament on Sunday, October 6th at 1:30 p.m. at Community Park.

Mr. Smith reminded everyone of the Relay for Life event on Friday, October 4th at 5:30 p.m. on Morrison Parkway.

Mayor's Report

Mayor Dukes reported that he will be appearing at the school board meeting regarding Rosenwald Park and an MOU (Memorandum of Understanding) to maintain the park.
